This Privacy Policy explains our practices regarding the collection, use, and disclosure of information through WordXplore (the "Game") on any device. Children's Privacy

Consistent with the Children's Online Privacy Protection Act ("COPPA") and other privacy laws, we do not knowingly collect any personal information from children under 13.

Information We Collect

In alignment with our privacy practices, we do not collect any personal data from our users.

The Game uses <u>GameAnalytics</u> to track gameplay and progression anonymously to enhance the gaming experience. This tracking is limited to:

- Gameplay and progression data to understand user engagement and to improve game features.
- Device type and operating system for optimizing game performance across various devices.
- Anonymized IP addresses for analyzing general user trends and game performance.

In addition to using GameAnalytics for analyzing gameplay and progression, our Game also integrates <u>Sentry</u> for the purpose of tracking errors and crashes. This helps us maintain the quality and performance of our Game. Here is a summary of what is collected by Sentry:

- **Error Reports:** When the Game encounters an error or crashes, Sentry collects data related to the current state of the Game, which may include details such as the type of error, where in the Game it happened, and technical information about your device (e.g., device type, operating system version).
- Technical Information: To help us understand the context of an error or crash, Sentry may collect certain technical information about your device. This includes device type, operating system, and other similar non-personal information.

No personally identifiable information (PII) is captured at any point during the use of the Game.

Use of Your Information

The anonymous data we collect through GameAnalytics and Sentry is used solely for the following purposes:

- **GameAnalytics:** To analyze gameplay and progression data, which helps us understand user engagement and improve game features.
- **Sentry:** To track errors and crashes within the Game. This information is crucial for diagnosing issues that affect the performance and stability of the Game, allowing us to promptly address and fix these problems.

Disclosure of Your Information

We are committed to not selling, trading, renting, or otherwise sharing your information with third parties for marketing purposes. The anonymous, aggregated data we collect may be shared with partners or third parties in the context of improving the Game's functionality or for business analysis. This data is not personally identifiable.

Data Security

We take reasonable measures to protect the security of the anonymous data collected through our Game. While we strive to use commercially acceptable means to protect your information, we cannot guarantee its absolute security. The integration of GameAnalytics and Sentry into our Game is performed with a strong emphasis on safeguarding all collected data, ensuring that only necessary, non-personal information is captured for error tracking and gameplay analysis purposes.

As we do not collect personal information, typical rights related to accessing, correcting, deleting, or transferring personal data do not apply within the context of our Game.
